Funding has been provided by proponents for the recapitalisation of the Company on an "as needs" basis for costs associated with bringing the Company up to date for reporting requirements and for meeting other needs associated with the proposed recapitalisation. Funding is repayable upon successful recapitalisation of the Company and without interest. Funding is unsecured with the exception of \$69,000 which has been secured against the tenement. Future costs associated with the recapitalisation proposal are intended to be met by further funding by the proponents of the recapitalisation or other interested parties.


